I hereby acknowledge and agree that if I am found, after following the applicable institutional disciplinary process, to have organized, led, participated in or facilitated an unauthorized dharna/protest/demonstration or other serious disruptive activity covered by this undertaking, the College may impose a disciplinary penalty of up to ₹5,00,000/- (Rupees Five Lakh only), as provided under the applicable College rules/policy and subject to applicable law and the decision of the competent authority.

Where any actual loss, damage, repair cost, legal expense or other recoverable loss is caused by my act or omission, I and/or my parent/guardian shall be liable for such amount to the extent permitted by law and the applicable institutional rules. The above disciplinary penalty shall not prevent the College from taking any other disciplinary or legal action available under applicable rules/law.

6. SUSPENSION AND OTHER DISCIPLINARY ACTION

I understand and accept that, depending upon the nature and gravity of the misconduct and subject to the applicable disciplinary procedure, the College may take appropriate disciplinary action, which may include warning, fine/penalty, suspension from classes or other institutional activities, withdrawal of specified privileges, hostel-related action, or any other action permissible under the applicable rules and law.

In serious cases, the matter may also be reported to the appropriate statutory, regulatory, police or other competent authority wherever required or permitted by law.

7. RESPONSIBILITY OF STUDENT AND PARENT / GUARDIAN
